Re: Randy White, MP

Please be advised that our firm acts as solicitors to Randy White, MP. As you of course know, Mr. White was interviewed by you in May of this year for your upcoming film, “Let No One Put Asunder” (the “Film”). The release of extracts from your Film together with comments by Velma Cole of Aldergrove during the final days of the June 2004 Federal General Election have caused Mr. White considerable damage to his reputation, not to mention anxiety, embarrassment and consternation. It is Mr. White’s position that the comments made by Velma Cole are not accurate and that the extracts from your Film have been used by you, Velma Cole, or others, in a manner detrimental to Mr. White.

Mr. White is currently considering the implementation of legal action for defamation against some or all of those involved in this matter. He has instructed us to advise you that he withdraws his consent for you to use his name, interview material, voice or image in any documentary or other film. As a result of his comments being taken out of context and used to his detriment, he does not believe that this material would be used fairly and that the use of same would only further damage his reputation unjustly.

He has also requested us to advise you that any comments he may have made only express his own personal views and are not the position of the Conservative Party of Canada.

Mr. White requests that you provide to us a full copy of the raw footage of the interview you taped with him in its entirety so that he might review same in considering how he might proceed herein.

Please be on notice that any further broadcast or distribution of defamatory comments or Film footage constituting defamation may result in legal action being commenced for all losses, costs, expenses or damages incurred by Mr. White. These actions may be pursued against you, your company, any media outlet broadcasting or otherwise distributing the material, and any third parties (such as Velma Cole) who may have been or become involved in this matter. Mr. White and ourselves will be carefully monitoring this matter to determine whether or not further defamation occurs. Please govern yourself accordingly.
