ONLY GAY PEOPLE CARE ABOUT GAY RIGHTS. JUST LIKE ONLY BLACK PEOPLE CARE ABOUT CIVIL RIGHTS.

"It should be recalled that at one time African-Americans were entitled to sit on the same bus as 'whites' and in seats that were equally comfortable to other seats. They just could not sit at the front of the bus because those equal seats were reserved for 'white people'. As well, African-Americans were entitled to drink water and use toilet facilities that were in all other respects equal to those used by white people. Once again, they could not do so from the same fountain or use the same toilet as 'whites'. Each of those were – although once seemingly credible concepts – discredited and rejected by courts in the United States."
